REQUIREMENTS FOR CONTRACT TIME

1. Confirm via email by Saturday, July 31st that you wish to renew your current contract court time. Contract members must have an Active membership with the MLTC East by the start of the contract. You will be notified when membership registration opens for 2021-2022. If a player without an active membership shows up, they will be expected to complete the membership purchase or pay the guest fee PRIOR to going on the court.
2. Any MLTC East member may substitute during contract time at no additional cost. Non-members subbing must pay an \$8 guest fee. Courts are monitored and your contract can be revoked without refund if you do not adhere to this policy.
3. A **non-refundable deposit of 50%** is required to reserve the court time for the contract period. **This amount will be put on the contract representatives billing statement and payment will be charged to the credit card on file upon your request to renew. If you would rather pay the deposit by check you must let me know in your email when you request to renew; if you do not then the credit card will be charged by default.** If MLTC is unable to fulfill the contract as requested, the deposit WILL be returned; this is the ONLY situation in which the deposit shall be refunded.
4. **The balance will be put on the contract representatives Sept. 1st statement and payment will be charged to the credit card on file on Sept. 15th unless payment has been received prior to that date by other means.**
5. Both the deposit and balance must be paid in its' entirety by the contract group representative. We will not be responsible for collecting from the individual members of your group.

**All applications are subject to the approval of MLTC. Limited courts are available for contracts. MLTC reserves the right to deny any contract that it does not deem to be in the best interest of the club, without explanation. Exact court assignments will be at the complete discretion of the management.*

**Please note that "makeup" dates or refunds are not offered for missed dates. If MLTC must cancel a contract date (due to weather or other circumstances) a credit will be issued to the contract representatives account.*

Please provide us with the full names of your regular contract participants by September 1st. For doubles you must list a minimum of 4 players, for singles a minimum of 2. That information can be emailed to me directly.
